ASCF SPEEDWAY SEDANS AUSTRALIA INC – CODE OF CONDUCT FOR ALL PARTICIPATING COMPETITORS



BEHAVIOUR AT RACE MEETING:

- Always comply with the rules
- Competitors are responsible for their own conduct as well as the conduct of any person associated with them, such as, Pit Crews, Vehicle Owners and Sponsors
- Most Stewards have volunteered their services for the smooth, efficient and fair conduct of the race meeting
- Avoid arguing with a Steward if you disagree with a ruling, quietly check with the Official on how the decision was reached
- Control your temper verbal and physical abuse of stewards or other competitors and deliberately distracting or provoking others is not acceptable or permissible behaviour
- Treat all competitors as you would like to be treated do not interfere with, bully or take advantage of any other participant
- Avoid the use of coarse or derogatory language

PREPARING TO RACE

- Driver is responsible for car owner and crew at all times at race meeting
- Driver and crew must be dressed in appropriate clothing and foot wear
- No smoking in Pit Area and track arena unless in designated area

SCRUTINEERING

• Track scrutineering will be conducted at the allocated area and within the allocated time period

WORKING ON CARS

• Driver and crew working on race cars in a safe manner and using safe methods at all times – eg jack stands, approved fuel containers etc

RACE TIME

- Bring race car to dummy grid when called at a safe pace
- Driver to be ready to race with seat belts tight and helmet and other safety equipment secured

AFTER RACE HAS FINISHED

Driver to leave race track at a safe speed and must not break traction when driving in the Pit Area

- 1. Please print clearly in all areas. All forms must be FULLY completed and legible to be accepted.
- 2. The Code of Conduct **MUST** be signed on the reverse of the front page to be accepted.
- 3. This form is to be returned via one of two options
 - Option A through a Club affiliated to the QSCA Inc
 - Option B directly to the QSCA Inc Licencing Secretary, to the address shown on the front of this form.
- 4. Paperwork forwarded directly (using Option B) to QSCA Inc Licencing Secretary will be issued and returned via the nominated QSCA Inc affiliated Club shown on the front of this form. Payment must be attached with applications sent via this option.
- 5. If insurance is **NOT** applied for this with application a copy of your current insurance card **MUST** accompany this application.
- 6. The issue of your competition licence / infringement card will not take place until confirmation of your current insurance has been received by the QSCA Inc.
- 7. Modified Production, Super Sedan, 4 Cylinder Sedan or Junior Sedan it is mandatory for competitors be the holder of an ASCF/SSA Inc Infringement Card Infringement Cards will have a common renewal date matching the expiry of the applicants PA insurance cover.
- 8. Street Sedan, Super Street Sedan, Junior Street Sedan, Nostalgia Sedans it is mandatory for competitors to be the holder of a QSCA Inc Licence / Infringement Card. Infringement Cards will have a common renewal date matching the expiry of the applicants PA insurance cover.
- All applications received from Junior competitors MUST be signed by a Parent or Guardian.
 First time applications from Junior Drivers must be accompanied by a copy of the Birth Certificate.
- 10. Upgrades from QSCA Inc Passenger Only to QSCA Inc Driver Licence / Infringement Card and Junior to Senior will incur a \$10 upgrade fee.
- 11. A Fast Track fee of \$55 applies to any application received by the Licencing Secretary within 14 days before the registration / licence / infringement card is required.
- 12. Applications to register all cars must be accompanied by the current Daylight Inspection not completed more than 30 days previously.
- 13. If you are re-registering your Junior Street Sedan, Street Sedan, Super Street Sedan or Nostalgia Sedan you **MUST** return your 11/12 Log Book so your Log Book can be updated, it will then be returned to your Club, applications for re-registration received without the 11/12 Log Book <u>will not be processed</u>.
- 14. The owners name on the Daylight Inspection and Engine Sealing forms **MUST** be the same as the Application for Registration form. If there is a variance the paperwork <u>will not be accepted</u> it will be returned.
