a) pg. 3 - 4.1.2 — Roof numbers Super Sedans only have exemption from having roof top plates- 75mm number to be displayed on side of car & on rooftop — clarification as supplied by Bill Peall - *State SSA Technical*

Noted by Patricia Writer that manual lap scorers will still have problems with this, not all tracks have transpondering at every meeting.

- b) pg. 3- 4.2.5 Tyre cost limit for 4 Cylinder Sedans no action has been taken at this point in time remains as is cost under \$180 and no racing tyres.
- c) pg. 4 4.3.2 SSA has purchased channel 970 for Speedway use, though not all tracks are using this channel: Rockhampton,
- d) pg. 5 8.2.1 Junior Sedans Hold over to General Business
- e) pg. 6-13.2 Townsville motor sport facility at the showgrounds on a temporary basis until complex is built. Speedway Australia is happy with the fence they are utilising the concrete barriers on the top with fencing that are used for the V8 Super Cars races (in exchange for the storage fees) with a defined exclusion zone. Ashley Barron commented re existing tracks have to "jump through hoops" to run the new clubs pop up and are allowed to run Timber fences carry a spear damage risk, though the allowance of timber fencing is still in the current Track Operations Manual.

- b) pg. 4–11- Accreditation Allan Jennings Vice-Pres./State Chief Steward reported on the Speedway Australia Stewards Panel meeting; all classes represented, the National Stewards Accreditation proposed training would be far too long for people to gain accreditation and needs to be shortened. i.e. 20 meetings and 2 years as trainee to gain Assistant role. The training that Queensland offers is still relevant and will be ongoing.
 - The infringement notices issued by our officials were pulled apart and given no support from Speedway Australia. Allan Jennings proposed the we as a body suspend infringement cards only as Speedway Australia believe we have no right to suspend "Insurance" (Speedway Australia basically issues licences that come with "free Insurance".
 - Comment from Pam Franz encouraged all club officials to renew now as the issue of Red Cards is taking considerable time to go through, new photos to be supplied every three years for seniors, Sedan officials will still be registered to SSQ.
- c) Stewards Reports Gatton club advised that they send their reports straight to Speedway Australia requested that a copy to this State body would be appreciated.

6) Presentation of Financial Reports.

Discussion held - points/ questions raised -

Q/ Gatton – costs of travel and accommodation for state titles vary from track to track.

Response – some people don't claim expenses even when they are entitled to, distances travelled by and depending on the number of officials supplied from the local club as to how many officials have to be brought in to run the title. Many officials have dual jobs to keep numbers down.

Q/ Gympie – Take away the heat money paid at Titles, are we too cheap on the nomination fees? Response – general discussion – no action/decision.

Q/ South Burnett – Title prize money is not enough is still "in the dark ages"

Response – State Body will look at restructure of prize money as per the Modified Sedan Title.

Q/ South Burnett – Restructure so that all competitors get a minimum guarantee amount – worked well with the Modified Sedans, puts the money "down the line" more.

Response – will be looked at for future titles.

Q/ Coal Capital – Set the nomination fee to the same amount as the minimum guarantee payout? Response – general discussion – no action/decision.

Q/ Bundaberg – Why does it take so many officials to come to a National Title?

Response – A "package deal" is taken to undertake a National Title which includes officials as appointed by the National Body. Qld has the availability of more officials to support the National Title team whereas some other states do not.
