We will be working towards a session in the Southern part of the state, possibly 1 in Rockhampton and 1 in the far north to accommodate all officials.

I also now have our one way communicator units, we have bought two of them, one as a back up in case of failure and I believe Pam is investigating some headsets so we can trial them. We need to be proficient in using them before our 1st title on the 1st of Dec 2007.

I have been appointed the Chief steward for the national Modified Production title being held in Maryborough, along with Paul as ASCF rep, Terese as title coordinater and Bill as technical rep. As a group we are used to working together, we should have a great time. I look foward to Easter thats all for now

Pam Franz – Licencing Secretary

The 2007/08 season is proving to be as turbulent and trying as any other speedway season. With the first race meeting of the season in the south east corner just one week away paperwork is now coming to hand in great bundles even though the season officially began over 2 months ago.

After many complaints in previous years about the number of forms to complete I combined the Licence Application and Car Registration form into one – however, there seems to be a lot of confusion over what people need to complete. This form will continue to be evaluated and if necessary will revert to two separate forms next season.

I have attended the August General and Annual meetings at Chermside, a meeting with the 4 Cylinder Speedway Sedans in Nambour, a meeting with the East Coast A Grade Sedans in Caboolture and some Club meetings.

I have processed to this time:

- 33 Street Sedan Registrations
- 9 Super Street Registrations
- 1 Dwarf Car Registration
- 7 4 Cylinder Speedway Sedan Registrations
- 15 Registered Stewards
- 24 Registered Scrutineers
- 4 Registered Lap Scorers
- 3 Registered Pit Marshalls

Due to the heavy demand on finances at this time of the year I encourage Clubs to forward payment for Licences, Insurance and Registrations on a 14 day basis. This will help keep the money flowing without the need to transfer from our Investment Account.

Some Clubs have adopted the method of applying directly to NASR for their members requirements – unfortunately – this slows the process of issuing Infringement Cards and Licences due to the need to verify if current insurance has in fact been applied for. NASR do notify my office of insurance applied for directly from Clubs if they are for 'ASCF' level insurances – other levels are not notified to me such as 'B', 'A' etc. The majority of the licence issuing is done outside of normal business hours, to verify current NASR insurance held for these other people means an email being sent to gain the information. This paperwork finds it way to the bottom of the pile and is only processed when all other fully compliant paperwork is processed. To follow the correct process will ensure your members licences and log books are received in a shorter time frame.

The introduction of the new Australian Speedway Racing Rules book has bought yet another round of issues that we need to work our way through. This will change the face of speedway racing in Qld as we knew it before.

Myself and Rodney Midolo have been working with the Super Street drivers to put together a 5 or 6 Round Series in this season. A good response is to hand so far for this and it looks like being a definite. A number of drivers have pledged financial support to the end of Series prize pool. The financial side of the end of Series prize pool will be processed through the QSCA to enable businesses to be given a compliant Tax Invoice. The next step is to talk with tracks and set some dates.

The Modified Production Entrants Group have also approached the QSCA to look after the financial side of their current seasons Series to enable the supporting businesses to be given a compliant Tax Invoice

Wes Beadman – Sth Zone Rep.

It has been a very full few weeks since being elected.

To all those who have made me feel welcome...Thank You.

The major issue was of course going to be the "Amalgamation of Divisions 1 and 2 Street sedans and the Monthly meeting at Gympie certainly showed that the majority Members of this Club seemed open to the merger and have adopted this for the 07/08 Season.

The Sunshine Coast Club forwarded a letter to the Gympie Meeting and it was accepted into the meeting for discussion (I actually thought that it should not have as it wasn't correctly signed and the author could not be identified).

This letter was in opposition to the merger and carried several points that were given careful consideration by all at the meeting.

This matter will need our continued support for the Clubs to make it work, and as we agreed to support the Club's decisions, I can see no reason as to why this shouldn't happen.

An approximate 5000 strong crowd were given a "Jam Packed" event in which several classes were highlighted....Well done Maryborough!.

This month will see racing start for the 07/08 season and with the Modified Product and Super Sedans seeming to multiply in the of season the stage is set along with our own State Based Categories to be "One Hell Of A Year".

Diane McKeiver - Central Zone Rep

I have been enjoying a nice quiet time since the end of June, but do look forward to the commencement of racing again. Since my re-election as Central Zone Representative, I have sent a letter to clubs in Central Zone, outlining the role of a Zone Representative and offering my support.

Blackwater: Had scheduled their first race meeting for 8 September to be headlined with Sprintcars. Unfortunately this was postponed due to the much-needed rain and rescheduled for today.

CEO Neil Sayer gave a brief progress report of where the organization was from the last planning meeting held 2004.

As the day progressed participants were grouped and given some specific tasks to work through.

At the commencement of the meeting the ASCF/SSA had a mission statement and a mission statement. Participants voted to embrace a new mission statement:

'That the ASCF/SSA is the leading governing organization in speedway sedan racing, fostering promoting the sport throughout Australia. Providing unified management of Safety, Technical Specifications, Racing Rules, Training & Accreditation.'

Participants discussed if the organization was in a position to embrace the name change to Speedway Sedans Australia.

Most felt that the incorporated name would still be ASCF/SSA Inc trading as Speedway Sedans Australia.

Over the coming months and seasons the name ASCF would begin to disappear from logos/letterheads etc.

- Application of racing rules
- Safety standards
- Training and accreditation

Once the key issues were identified and discussed the group were able to work on the strategic objectives for the next 3 years.

SSA will continue to improve communication strategies designed to increase knowledge and awareness among drivers, officials and other stakeholders, and create opportunities for driver and stakeholder input.

Division 2 Title – The QSCA Inc will be running a Division 2 Street Sedan title this season. – Clarification – concerns from drivers there may not be a DIV 2 Title.

Cars may be 'dual' registered as Super Street Sedans/Street Sedans/Junior Streets however scrutineers will need to be vigilent on race night to ensure complicance to class specifications.

Modifications/Changes to Mothar Mountain track fenceline – following calls from concerned drivers the COM decided to go and have a look at the modifications to the existing fenceline. Paul phoned and arranged with club president.

After the inspection the meeting reconvened for discussion.

One Way Communicators – guidelines for the use of were added to policy. Memo to all clubs that all competitors nominating for a state title will be required to use a one way communicator. Drivers will need to have their own as whilst the QSCA will hire transponders, due to Health & Safety regulations there will be *no hire* of One Way Communicator radios.

He had provided them with a phone number to contact. Paul had offered to follow up with NASR re some of their queries.

Super Street Series – A total of 41 letters have been sent out to all registered Super Street drivers – responses received to date have been positive.

A discussion held on the use of the website to raise the profile of Committee of Management people, starting with the President & Vice President. Pam will draw up a profile sheet and all COM members are asked to return it to her.

Transponder training – still awaiting dates from SSA Inc. – once available they will be circulated and clubs encouraged to send someone to the training, to date we have approx 6/8 people interested, dependent on date and venue.

Tyres – Street Sedans – referred to the technical meeting – to formalize the updated list that Tony/Trish have been working on.

Racing Rule Book – The QSCA Inc will be using the new racing rules from the commencement of racing, Terese advised that many clubs had asked for the link and /or a copy of the new rule book.

Rule 2.2.6 will be an issue for the QSCA Inc however it is in the rule book and we will be following the rule.

Paul will do up a press release for the website.

There being no further business the meeting closed at 5.30pm.
