- a) pg. 1 as long as there is not six cars registered in 4 states a National Title for 4 Cylinder Sedans will not get put into the titles rotation.
- b) pg. 3- Gatton re titles costs Junior Title just held, there were only 2 local registered officials available all others had to be brought in and accommodated. Two local helpers did express an interest in becoming registered stewards.

Business Arising - SSA Phone Conference meetings 19 Nov 2014 & 21 Jan 2015

a) Registration of officials after Red Card System withdrawn.

Input from states is required – Qld will have an input at the upcoming Secretary's meeting with the SSA looking at a National system of registration for officials by July 1.

- Ideas 1. An online registration with SSA and then shared back to relevant State body. 2. Working with children Blue card is done by states first then to SSA with a system of review available.
- b) Resignation of board member Michelle Harris (NT) 25 cars registered in the State. They were only adding 50 cents to the cost of books etc. and so did not have any money. Michelle Harris lives in SA and used to pay her own way for conferences etc. Nothing has been received in writing.
- c) Registering cars to Juniors "application for registration of an SSA vehicle cannot be made by a person under the age of 18".

Immediate implementation – due to legal liability as the Junior is not responsible by law to sign. SSA will issue an official release for on forwarding.

Any junior that signs paperwork (log books) must be countersigned by a Speedway Australia licenced guardian/crew.

d) National titles – only 3 day allowance to be paid – Qld disagrees – have always been paid as 5 days previously.

Decision - Jim Cowley as board member to ask for a formal explanation as to why the extra 2 days were taken away.

e) Officials 15/16 – Engine sealers – no media release has been issued yet from the SSA.

No wire is available from anywhere - SSA is trying to source more supply. In Qld chief club scrutineer can seal. Registered engine sealers, most have businesses and are staking their business reputation on putting the name to engine sealing paperwork. Discussion held – not worth the time and effort it takes and from past experiences can be easily circumvented anyway.

Decision – Bill Peall to take to the next Tech meeting to be held as an agenda item.

- f) SSA Secretary/Registrars meeting to be held 28<sup>th</sup> March 2015. Pam Franz will attend Kaye Arthur not available due to son's engagement party.
- g) Roof numbers Super Sedans- send a request through Qld CTAC David Knight to have roof numbers allocated for ease of identification and due to duplication of numbers. NASCAR style side numbers?
- h) Identification of classes Suggestion to have class ID on windscreen visor as mandatory. Submit to Qld CTAC reps of sedan classes.

# Name change:
