NOMINATIONS CLOSE: Friday 25th April 2025 at Midnight AEST

LATE NOMINATIONS: Any nomination received after the above closing date will be deemed to be a late nomination. Any unpaid nominations after Monday 28th April 2025 will also be deemed to be a LATE NOMINATION. The Super Sedan late nomination fee is \$350 (non-refundable).

TOTAL NOMINATION/ADMIN FEE: \$100-00 including GST (NON REFUNDABLE)

With or without your own Transponder – FREE transponder for those who require a transponder to be supplied.

Finalised format will be dependent on number of nominations – the following format is for up to and including 60 cars.

FORMAT: ONE night meeting:

Each driver to have 3 heats

3 heats per driver

All heats will be maximum 10 laps

Maximum of 12 cars per Heat

Points - 36,28,23,17,13,10,8,6,5,4,3,2 and 1 to all other finishers

NO RESERVE CARS for any Heat or Main event

All drivers must only compete in the allocated Heat or Main event

A MAIN

1 x A Main event will be run over 40 laps

Top 16 qualifiers plus sufficient cars in finishing order from each of the B Mains to equal 22 starters plus the Defending Champion as per *Rule No 4.30.3 - The previous year's champion shall be allowed to defend title but must compete in heats. However, if the champion fails to qualify in this manner a rear of the field start is permitted in their own or a substitute car.*

B MAINS

2 x B Main events (Odds & Evens) will be run over 20 laps each

Qualifiers 17 – 60 to compete in B Mains with first 3 place getters from each of the B Mains to run rear of A Main. (Positions 17, 19, 21 and 18, 20, 22)

Odds – Point scorers – 17,19,21,23,25,27,29,31,33,35,37,39,41,43,45,47,49,51,53,55,57,C1

Evens – Point scorers – 18,20,22,24,26,28,30,32,34,36,38,40,42,44,46,48,50,52,54,56,58,C2

Note: If there are insufficient cars to hold the above B Main format it will be adjusted accordingly to suit the numbers of cars available on the night. If the defending title holder qualifies directly into the A Main the number of cars to transfer from the B Main/s will be adjusted to ensure there is 24 cars in the A Main.

STARTING OPTION: *Rule No 4.6.1 – In race formats where the highest point scorer starts the feature race on pole, the highest point*

scoring driver will be given the option of starting in either the inside or outside position of the front row.

Rule No 4.6.2 – The option must be exercised prior to the cars forming up on the dummy grid. There will be no change to any other starting position.

HEAT RACE RESTARTS – All Heat race restarts will be DOUBLE ROW restarts unless less than 2 laps to complete then restart reverts to single row/cone restart.

MAIN EVENTS RACE RESTARTS – Main events race restarts will be DOUBLE ROW restarts unless less than 5 laps to complete then restart reverts to single row/cone restart.

PRACTICE: No Hot Laps or practice will be available at this race meeting

DRIVERS BRIEFING: Will be held at 3.00pm (unless otherwise notified)

RACING FROM: Scheduled at 4.00pm pm (unless otherwise notified)

PRIZEMONEY:

No Heat Prizemoney or Tow money payable

21 Cars or More

A Main - 1st \$2000 2nd \$1200 3rd \$1000 4th \$500 5th \$400
6th \$300 7th to 24th \$250

B Main - 1st to 4th \$0 5th to 10th \$200

Up to and Including 20 Cars

A Main - 1st \$1500 2nd \$1000 3rd \$500 4th \$400 5th \$300
6th \$300 7th – 20th \$250

Cars must successfully pass scrutineering and having taken a green light in a Heat race to be eligible for minimum guarantee of \$150.

TROPHIES:

- Trophies 1st through 5th place in A Main
- Corflute Achievement Board for each Heat Winner – to be presented at completion of each Heat race by the infield commentator
- Corflute Achievement Board for A Main Pole Sitter – to be presented prior to A Main commencement.
- Corflute Achievement Board for remaining 23 starters in A Main – to be available with Log Book at time of collection of Log Book

SCRUTINEERING:

- Will be held at McCosker Gladstone Speedway, Gladstone in the designated area.
- Scrutineering will be conducted between approx. **10.00am and no later than 1.00pm on Saturday 10th May 2025 – must be in the scrutineering line no later than 12.30pm.**
- NOTE: **ALL CARS must** be available for inspection between the above times and all competitors will be allocated a scrutineering time after the close of nominations.
- Cars will not be accepted after 1.00pm, unless prior arrangement has been made with the SSQ State Secretary (0417 137 740) - Late arrival without notification will incur a penalty.
- Post Title race checks will be done at a time and place as directed by the Title Chief Scrutineer.
- All Title positions will remain unofficial until all post title race checks have been carried out to the satisfaction of the Title Chief Scrutineer.

LOG BOOKS:

Are to be handed to the scrutineer at scrutineering and obtained after the completion of the nights racing. Hired transponders must be returned to obtain your Log Book.

GRID DRAWS:

- Deemed to be carried out by Speedway Sedans Qld prior to the event.
- Grid draws will be available in the electronic program produced by the Host venue.
- All cars will use transponders at this event.
- Each car will use their regular car registration number.
- The number on the side of the car is to be 'clear easy to read' and must be the number of per the logbook.

TERMS and CONDITIONS OF ENTRY:

1. All entries MUST be via the online nomination system. Entries must be followed up within 3 days with payment of nomination fee of \$100 via EFT to Bank Account: Queensland Saloon Car Assn Inc Account Number 157104142 BSB: 633000. Payment by credit/debit card is available by phoning Treasurer Pam Franz on 0417 137740.
2. LATE NOMINATIONS – Any nomination received after the closing date will be deemed to be a late nomination and unpaid nominations not received within 3 days of the closing date will also be deemed to be a LATE NOMINATION - \$350 payable.
3. Driver must hold and provide for sighting a current Speedway Australia Driver Licence for the appropriate class. One Day Licences are NOT acceptable for State Title events.
4. Car must carry a current SSA Inc decal and logbook and be currently registered at time of close of nominations.
5. One Car / One Driver only are eligible for this event – Rule 2.1.2
6. Withdrawals must be notified to SSQ State Secretary, Pam Franz (0417 137 740) as soon as possible. Failure to do so will incur a penalty.
7. Prize money will be forwarded directly into your nominated Bank account, usually within 28 days of completion of the Title event, after a full clearance has been given by the Chief Steward / Chief Scrutineer for the event.
8. All drivers must complete the relevant GST Statement as part of the online nomination form. Please note that all, prize, tow or appearance money is stated in gross amounts. Where applicable 1/11th becomes the GST proportion liable.
9. Engine sealing is mandatory in SSA Sedans – exception National 4's.
10. One Way Communicators are mandatory – competitor to supply own One Way Communicator and battery.
11. The use of Transponders is mandatory.
12. Post Title race checks are to be done at a time and place as directed by the Title Chief Scrutineer.
13. All Title positions will remain unofficial until all post title race checks have been carried out to the satisfaction of the Title Chief Scrutineer.
14. Competitors and associated Pit Crew/family members are reminded of the Speedway Sedans Queensland and Speedway Sedans Australia and Speedway Australia Code of Conduct and social media Policy.
15. The Speedway Sedans Queensland reserves the right to accept or reject any nomination.
16. By signing the nomination form for this event I understand that the nominated driver and his/her pit crew may appear in visual media (i.e. photographs, video footage) that is undertaken inside the speedway complex and that it remains the property of the media personnel involved.
I also agree to any visual media involving the nominated driver and his/her pit crew to be used by the associated media personnel and/or Speedway Sedans Qld and Host Venue.
